

Privacy Policy

Textile Center of Minnesota has adopted this privacy policy with respect to information you provide when you use the Textile Center website, <http://textilecentermn.org>. The privacy policy outlines:

- What personally identifiable information is collected from you through the website, how it is used and with whom it may be shared.
- What choices you have regarding the use of your information.
- The security procedures in place to protect against the misuse of your information.
- How you can correct any inaccuracies in the information.

When ordering products or services, making donations, becoming a member or registering on our site, as appropriate, you may be asked to enter Contact Information (your name, e-mail address, mailing address and phone number) or sensitive information such as credit card information. You may, however, visit our site anonymously.

Information collection and use

Any of the Contact Information or sensitive information you provide to us on this website may be used to provide the items or services you requested, process donations / memberships or other transactions, improve customer service and send periodic communications.

We will not sell, exchange or transfer your information to any third party, other than as needed to deliver the product or service you requested, process your donation / membership or another transaction you requested or as provided below.

We may share your Contact Information with trusted third-party vendors to help us send you email and postal mail, provide the goods and services you requested, process your donation /membership, perform statistical analysis or provide customer support or other services. These vendors are required to keep this information confidential and use it solely for the intended purposes.

Unless you ask us not to, we may contact you via email or mail in the future to send you news, updates, and new offerings related to the Textile Center.

Information security

We implement a variety of security measures both on-line and off-line to maintain the safety of your personal information when you place an order, access your personal information or make another transaction using the website.

We use a secure server. All supplied sensitive/credit information is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our Payment gateway providers' database that is accessible only by those authorized with special access rights to such systems, and are required to keep the information confidential

After a transaction, your sensitive information (such as credit card information) will not be stored on our servers.

We use cookies to help us remember and process the items in your shopping cart, understand and save your preferences for future visits and compile aggregate data about site traffic and site interaction so that we can offer better site experiences and tools in the future. You can change your browser settings to have your computer warn you each time a cookie is being sent or to turn off all cookies. In that case, some of our services may not function properly. However, you can still place orders and make other transactions by telephone.

Sharing

From time to time, Textile Center may publish list of donors and / or members who make donations and /or become members via this website, by phone or by mail (for example, as part of our Annual Report). This listing may indicate a monetary range into which each donor's gift or membership level falls. If you wish to be excluded from any such listing, contact us as indicated below.

We share aggregated demographic information with our partners and funders. This is not linked to any personal information that can identify any individual person.

We may also release your information without notice to you when we believe release is appropriate to comply with the law, enforce our site policies, or protect our or others' rights, property, or safety.

Opt-out

You may also see what information we have about you, if any; change / correct any data we have about you, have us delete any data we have about you or express any concern you have about our use of your data.
